

Cannabis Reform Medical & Adult Use

What to expect in Maryland on July 1, 2023







When will Adult Use cannabis sales start?

July 1, 2023 for adults over the age of 21 who provide valid identification.



Must you be a Maryland resident to purchase Adult Use cannabis?

No, you are not required to be a Maryland resident, but must provide identification that you are over the age of 21. Medical cannabis patients must be Maryland residents.



Where will Adult Use cannabis be available for sale?

Adult Use cannabis can only be sold and purchased at licensed dispensaries. Existing Medical cannabis dispensaries will be converted to enable the sale of both Medical and Adult Use cannabis. New dispensary licenses will be issued starting in 2024.



How will cannabis sales be taxed?

Adult Use sales will be taxed at 9%. (The same as alcoholic beverages)

Medical cannabis sales will continue to be untaxed.

(The same as medicine)



How is the Medical cannabis program impacted?

The new Maryland Cannabis Administration will oversee the registration of certifying Providers, qualifying Patients, and Caregivers. Under age qualifying Patients may continue to obtain Medical cannabis through a caregiver or designated school personnel.



Will Medical cannabis Patients be prioritized at dispensaries?

Licensed dispensaries will have processes in place to prioritize Patients which may include dedicated store hours and/or priority shopping, and dispensaries must ensure an adequate supply of product for qualifying Patients and Caregivers.



What are the personal use allotments for Adult Use compared to Medical cannabis?

Adult Use: 42.5 grams (1.5 oz) of cannabis flower, up to 12 grams of concentrated cannabis, or a total amount of 750 mg of THC for cannabis infused products.

Medical: 120 grams (4.25 oz) of cannabis flower or 36 grams of THC for cannabis infused products.



Will there be any potency or dosage limits for Adult Use?

Potency and/or dosage limits have not yet been determined. The Maryland Medical Cannabis Commission (MMCC) will be responsible for determining potency limits for Adult Use cannabis.


